POSITION SNAPSHOT

The Research Data Officer (RDO) is a key role in supporting a large multi-country study - <u>PEARLS</u> - to ensure that data integrity and data quality are of the highest standard. The RDO will support the development and implementation of electronic data capture tools in REDCap, producing manuals, performing data monitoring, reporting, visualisation and curating data-sets for the study. They will work closely with multi-disciplinary teams at Burnet and international collaborators, including trial managers, data managers, healthcare workers, researchers, and statisticians to ensure the quality of the data.

In addition to the PEARLS study, the RDO will support data management activities and advise other research teams across the institute to implement best practices to ensure research data is efficiently and effectively utilised and compliant with ethical standards, privacy, data management policies and industry expectations.

KEY RESPONSIBILITY AREAS

- Perform data monitoring and quality checks for the PEARLS study including preparing weekly/monthly/ad hoc reports/data, reviewing data quality and querying data
- 2. Contribute to development and maintenance of study databases and any other databases or systems that are required for the efficient running of the study
- Participate in PEARLS co-ordination and data monitoring meetings with the Burnet team, project sponsors and international research collaborators.
